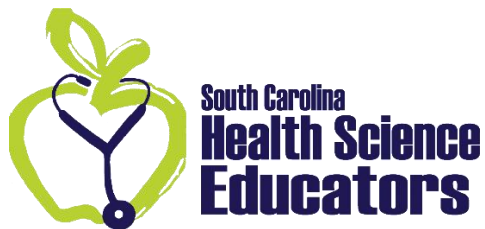

- DEPARTING AFTER LUNCH ON TUESDAY IS ACCEPTABLE

CANCELLATION: YOUR EXHIBITOR SPACE MAY BE CANCELED IN WRITING PRIOR TO OCTOBER 25, 2025, IN WHICH CASE FIFTY PERCENT (50%) OF THE RENTAL FEE WILL BE RETAINED BY SC HSE. CANCELLATION AFTER THIS DATE OBLIGATES THE EXHIBITOR TO FULL PAYMENT.

CLARIFICATION OF RULES: ALL MATTERS OR QUESTIONS NOT COVERED BY THIS APPLICATION SHALL BE SUBJECT SOLELY TO THE DECISION OF SC HSE. SC HSE MAY CHANGE THESE RULES AND REGULATIONS AT ANY TIME AND SHALL BE BINDING TO THE EXHIBITOR.

LIABILITY: NEITHER SC HSE NOR REPRESENTATIVES WILL BE RESPONSIBLE FOR ANY INJURY, LOSS, OR DAMAGE THAT MAY OCCUR TO THE EXHIBIT OR PERSONNEL.
